- 3) IP Trials 2013

The short notice to the change of date and venue for the 2013 Inter Provincials was disappointing. However this is something we have to work with so we shall push the date out to 15/16 June which will allow partnerships to become further established.

As it is now a 4 person team it is important to note on the entry that there are no reserves so be prepared to play for 2<sup>1/2</sup> days. The Regional Committee will let the successful trialists know which team they will be playing for.

- 4) Cromwell Bridge Club change of dates for 2014 Pairs Tournament to 15 Feb and cancellation of Teams Tournament for 2014

The change of dates was agreed in principal, however there is an alternative date in April that has become available. Ann-Louise will talk to them to see if this is more suitable.
