#### Programme

Also suggestion of trophies on a Monday night limited to players classed as Juniors by NZ Bridge.

A sub-committee could be formed for other suggestions.

One handicap was requested to be reviewed by a member and agreed upon.

Discussion also about visitors playing on Monday nights – agreed that Director should assign a -8 handicap to experienced players.

Also need to look at rules as rule 14 mentions 3 consecutive visits. Felt the word consecutive should be deleted. Also brief discussion whether 3 visits was too short a time.

Wednesday nights: Christine also reports: As partnership officer, I managed to get 3 new partnerships for Champ Pairs last Wednesday and we had 11.5 tables. I will continue to be as proactive as I can on other Wednesday nights. A note to be put in newsletter to remind anyone available to play on a Wednesday night to ring Christine.

Tournament –  $19^{th}$  March – Open B Grade Tournament. Notices have been emailed out. Lyndsay to direct. Girls organised for afternoon tea. Will get sandwiches and savouries from usual source.
