#### **Notes about the New Rules:**

Murray Wiggin has formulated a document with a brief outline of the changes in the 2017 rules. I will summarise them for you:

- The bridge board should remain *correctly oriented* in the middle of the table.
- Dummy may now attempt to prevent an irregularity by any player, but is still unable to draw attention to an irregularity which has occurred until play concludes.
- The director now has powers to award an *assigned* adjusted score enter a bridge result rather than an adjusted percentage.
- If a player gives an incomplete or incorrect explanation of their partner's bid, they must call the Director prior to the opening lead to correct their explanation. Players are not permitted to enquire about a call if the sole purpose is to elicit an incorrect response from the opponents.
- Comparable bid is the new buzz word and many of the changes in laws are around this. A comparable bid is one that has the same or similar meaning attributed to the withdrawn call, or defines a subset of the possible meanings attributable to the withdrawn call or has the same purpose. Comparable bids applies to an insufficient bid, a pass out of rotation, bid out of rotation, double or redouble out of rotation, and call withdrawn. If the bid is replaced with a comparable bid then there is no further rectification. Previously insufficient bids were replaced with a bid in the same suit at the lowest level otherwise partner couldn't bid again so this is quite a change.
- Legal and illegal changes of calls. This law has become more stringent and loss of concentration is specifically mentioned. It is not a justification claiming that a call is unintended.
- If dummy plays a card that Declarer didn't name, then it must be corrected before defenders play to the next trick.

- Players may now look at, but not expose, the card they played to their last trick, until either player from their side has played to the next trick.
- Claim or concession of tricks a hand can now be played out following a claim but only if a member of the non-claiming or non-conceding side requests the hand to be played out, and all 4 players concur otherwise the director should be called.
- It is now an infraction to state that there is a partnership agreement when there isn't one e.g. I'm taking that as ..." You are better to say something like "not discussed".

If you haven't discussed this with your partner, do it now

You are entitled to disagree, but your partner needs to know.
