NOTES FROM THE COMMITTEE:

- Welcome to new members: Jo Burnside and Michelle Taylor. Please continue to make these new members feel welcome.
- Our B Grade tournament will be on Saturday 22nd July and it would be great if we had a number of entries from our own club. Please enter online.
- Have you ever stopped to think of how much work is done behind the scenes by our Treasurer Avril? She needs a huge pat on the back. A huge part of her job is the table cards. The system works really well but there is a lot of behind the scenes admin work that goes on e.g. checking emails, texts, verbal communication, invoicing, receipting, reconciling and so the list goes on. What can you do to help? It would be greatly appreciated if you could pay online for your table cards. Remember paying online means you get 11 tickets for the price of 10 which doesn't apply if you pay cash. The reason for this is that the physical banking side of things is quite time consuming which is not helped by the banks only being opened limited hours on limited days. Cash has to be counted and separated into denominations and coin amounts. With this in mind if you do bring cash to bridge please only bring gold coins or notes.
- The WiFi system is being looked at to see if we can make it more stable.

WHAT HAPPENS IF THERE IS A DISAGREEMENT ABOUT HOW MANY TRICKS HAVE BEEN WON?

There is no need to say anything during the play.

If you have counted and don't agree then call the director **<u>before</u>** you do anything to the cards. If you remember which trick is the problem it is helpful but not necessarily.

Interestingly, Law 42 A 2 states that dummy "may keep count of tricks won and lost" which suggests that it is up to declarer and the two defenders to agree!

Dummy "may try to prevent an irregularity" (Law 42 B 2) so there is a short time interval that he can draw attention to a declarer about to place the card the wrong way.

Law 65b3 states that: A player may draw attention to a card pointed incorrectly, but this right expires when his side leads or plays to the following trick. It must be done at the end of the round.

Law 65D says: A player should not disturb the order of his played cards until agreement has been reached. A player who fails to comply with the provisions of this law jeopardises his right to claim ownership of doubtful tricks - or to claim or deny a revoke.

And no player is permitted to handle any cards but his own!!

CALLING THE DIRECTOR

Whenever an infraction has occurred the Director should be called. It is not unusual to hear players making their PRECTOR. PLEASE own rulings and so often they are wrong!! When calling the director, it would be a common courtesy to add the word "please".



While players might be offended to be accused of cheating, that is virtually what is happening when they make comments like "I don't know what to do here." or "Oh well, in for a penny in for a pound" or "We might as well give it a go" or any other such comment which is giving unauthorised information.

Some have the opinion that it is unfair to call the Director to new players! It is unfair NOT to call the Director to infractions. It is the only way to ensure equity.
