Trial bids

We've all had auctions like 1H - 2H - 3H, where opener bids one of a major, responder gives a single raise, and opener invites game by rebidding his suit at the 3-level. Responder passes with a minimum and raises to game with a maximum, and hopefully the partnership will land in the right spot.

As an example, consider the two E/W hands below after West opens 1S. East raises to 2S, and West – with 16 HCP and six losers – invites game with 3S. On Hand A declarer has an easy 10 tricks, losing only a diamond and two clubs, but on Hand B declarer must lose two hearts along with one in each minor for a maximum of nine tricks. Yet the West hands are identical, and all three East hands have the same point count (7), the same shape, and the same number of losers (9). How does the partnership bid the safe game on Hand A, while avoiding the hopeless game on Hand B?

Long suit trial bids are a way of solving this problem. After a major suit has been raised to the two level, a long suit trial bid is a change of suit by either partner. The final bid in each of these sequences (which must be alerted) is a trial bid:
(a) 1H - 2H - 3C; (b) 1H - 2H - 2S; (c) 1C - 1H - 2H - 3D.

What does the trial bid mean? It is an invitation to game in the agreed major suit, and shows a second suit – with at least two losers – in which declarer would like some help from responder. For example, sequence (a) above says "I'm interested in 4H but need help to cover my losers in clubs".

Your response to a trial bid – which is 100% forcing – depends on how many losers you have in the trial suit:

With no losers in the trial suit: bid game in the agreed major;

With one loser in the trial suit: bid game in the agreed major;

With two losers in the trial suit: bid game if maximum (8-9), otherwise sign off at the three level;

With three losers in the trial suit: sign off in three of the agreed major;

In the two example hands shown, after the auction begins 1S-2S, West should continue with a trial bid of 3H to alert East to his string of losing hearts. On Hand A, with only one heart loser despite his meagre 7 points, East bids game. On Hand B, with three heart losers, East signs off in 3S. In both cases, the trial bid guides the partnership to the correct contract.
