

Bridge advice from Martin

A Multitude of Contracts

During a recent beginner's lesson, teacher Clare Scurr made the point that much as we try to bid our hands consistently and correctly, there is always plenty of scope for individual judgement and partnership variation. For this reason, she told the class, it is very rare to find a deal where the same contract is reached at every, or even most tables.

A striking example of this was Deal 9 from the first night of the Glendhu pairs, where 9 different contracts were reached at 11 tables:



At our table, North opened a pre-emptive 3D, East and South passed, and West balanced with 3H. North passed, having nothing further to say and East also passed, expecting that to end the auction. With 3-card heart support East might consider a raise to game, but with a shapeless hand and soft values a pass seemed the best option.

But South wasn't ready to pass the hand out, and climbed in with 3S. Neither West nor East could muster another bid, so 3S became the final contract.

West began the defence by cashing her two winning clubs, then switched to a heart which declarer won in hand. He then led the diamond jack to dummy's ace, and continued by ruffing a small a small diamond in hand, noting the fall of East's king. He then ruffed a losing heart in dummy, and continued with the established diamond queen, over-ruffing east's spade 7 with the 10.

With five tricks in the bag, declarer now needed 4 of the remaining 6. When he led a small club, West was helpless. If she ruffed small dummy would over-ruff, but if she ruffed with the king that was the end of her natural trump trick and still left declarer with two trumps on the table. Regardless of what she did, the defence could never take more than two tricks, giving declarer his contract.

So well bid and well played by South, for a score of 90%. And the other scores on the hand? N/S also played in 3D, 4D, 4S, 5D, and 5DX, earning scores ranging from +110 to -300. Some E/W pairs were left to play in 3H, earning +140, while one pair pushed on to 4H going one light. And spare a thought for the unfortunate E/W pair who competed to 4C, going for -400 when the defence found their red suit cross-ruff.!

A reminder from the Directors

'Staking a Claim'

Declarer is encouraged to 'claim' a contract (whether made or lost) as soon as Declarer knows that they hold the rest of the winning tricks.

To do this, Declarer should be very sure that there are no trumps still out.

You often hear the words 'the rest are mine'; or 'I can claim'.

When Declarer 'stakes their claim' - they then MUST announce exactly how they intend to play the balance of the hand.

This may be - 'I can claim. No matter what you play, I have the top cards in D/H/C, & I will ruff any Spade lead. There are no trumps out'.

Or it could be; 'I can claim. I am going to crossruff any lead sent to me'.

It is not permissible, to 'claim' without providing an explanation, & showing the cards in your hand.

Occasionally, a defender will ask for the contract to be 'played out'. It would be better not to do this, but listen to Declarer's explanation - as penalties can be claimed should Declarer not be in a position to win the balance of the tricks.

If a Defender still holds a trump - ask the Declarer to repeat their strategy of play; then if Declarer hasn't mentioned about taking out the last trump & you are in a position to trump one of their winners, call the Director.

If you are correct, then penalties will be awarded - & you will be justly rewarded! 'Claiming' requires diligence on behalf of the Declarer & the Defender!
