# From New Zealand Bridge Chair- Allan Morris

New Zealand Bridge have asked all clubs that we publish the following in our newsletter

"Be kind and polite to your partner and to your opponents. We should not condone in any way bad or inappropriate behaviour. What I hear all the time from beginners is inappropriate behaviour puts them off joining and playing. So I ask before you say anything or act in any fashion that might be discourteous or offensive or inappropraite, please think!! "

We then received this message to publish

"I have emphasised the importance of appropriate behaviour at the table. Regrettably the message is not being picked up. Over the last few weeks we have a number of instances where the behaviour at the table was far from acceptable. The Board has a zero tolerance for inappropriate behaviour and will enforce regulations at our disposal. The Board has an expectation that senior players, in particular, will lead by example. Beginners, juniors, intermediates and many open players are influenced by the actions of our senior and supposedly more experienced players. So please stop and think before you do or say anything. If something untoward happens at the bridge table please call the director and allow them to deal with the situation.



## **Bridge advice from Martin An Unmakeable Contract?**

The following deal from the last night of the Aspiring Stakes featured a 3NT contract which proved to be eminently makeable despite ugly breaks in three of the four suits:



At our table East opened 1H after initial passes by West and North, and – with N/S silent – the auction continued 1H - 1S - 2H - 3D - 3NT. West's 3D - a new suit at the three level – is something of an overbid as it is virtually game-forcing, leaving East will little choice but to grit his teeth and bid 3NT, which became the final contract.

On lead against 3NT South was well aware from the auction that spades, hearts, and diamonds were all breaking badly. He tabled the diamond queen in the expectation that declarer would have serious communication problems. Needless to say, this view was shared by declarer when dummy was tabled. Winning in dummy, declarer cashed the heart queen, and surveyed his prospects. As long as the heart jack fell in three rounds nine tricks were there for the taking, so he returned to hand with the spade jack to the ace, North also playing small. On continuing hearts and discovering the bad break he realised that North would make a trick with the jack. So time for Plan B.

With eight spades in the two hands and South having followed to the first round declarer knew that North had started with at most four spades, so could be end-played. He threw North in with a small heart and had to suffer the indignity of watching North cashed his three top spades, but when North had to exit with a club he was able to win in hand, cash his last two hearts, and cross to dummy's diamond king for a total of nine tricks and a top board.

In retrospect, declarer can make life much easier for himself by overtaking dummy's heart queen in hand and conceding a trick to the heart jack while he still has control in the other three suits. This is a good example of a safety play, foregoing any chance of an overtrick but guaranteeing the contract regardlesss of how the spades lie.

### A reminder from the Directors

<u>Dummy's Rights and Wrongs by Matthew</u> McManus

Occasionally, perhaps unwisely, you have to let partner play a hand. As you watch from your position as dummy, you may experience a degree of apprehension. In this article, I would like to describe what the laws say you can and cannot do while you are dummy.

After the opening lead is faced, dummy places his cards face up on the table, sorted into suits with the lowest cards closest to declarer, and with trumps, if any, on dummy's right.

Apart from this, there are no other requirements in the laws as to the arrangement of the suits.

There is nothing which **demands** that the suits must be placed black/red/black/red or spades/hearts/diamonds/clubs, as some players seem to believe.

One thing that dummy should ensure is that all 13 cards are visible. If the defenders mis-defend because one of dummy's cards is hidden, then the director is likely to rule in their favour.

# During the play, dummy is significantly limited in what he is able to do.

One right that dummy does have is to attempt to prevent an irregularity from occurring. So, if you see partner about to play a card from his own hand when the lead is in dummy, or if he is about to call for a card from dummy when the lead is in his own hand, you can pipe up and try to stop him. However, once the irregularity has

occurred, you can no longer say anything - it is up to the defenders to point out the infraction. So if declarer calls for the "ace of spades", you don't say, "You're in hand". You should just play the AS and let the other players say something if they notice.

Secondly, as dummy, you may check that partner hasn't revoked when he fails to follow suit. This is usually accomplished by dummy saying something like, "No clubs, partner?" and declarer confirming that he hasn't revoked by replying, "Having none." (Note that this right to check is lost if dummy has done something foolish like looking at declarer's or a defender's hand.)

## Otherwise, dummy is just there to play the cards on Declarer's instruction.

Dummy may perhaps ask declarer to repeat the card he called for if he (honestly) didn't hear. Apart from that, dummy is seriously restricted in what he can say or do during the hand.

# Some of the things that you might want to do, but CANNOT include:

- Tell partner he has a trick pointed the wrong way after a lead has been made to the next trick
- Play a card before it is called for by declarer (even if it is a singleton)
- Express surprise at partner's choice of card from dummy
- Encourage partner to play dummy's little card which you know is good, but he doesn't seem to
- Call the director before anyone else has drawn attention to an infraction
- Ask a defender if he has revoked
- Ask partner if they have seen (and taken note of) the oppositions cards.

At the end of the hand, dummy now has the right to point out any infractions that he noticed during play. For example, this is the time when you can point out that revoke you saw that no one else did. But don't do it

beforehand as you may jeopardise your right to redress from the director.

### **Evacuation Procedures**

In the event of FIRE - Procedure for all members:

- If you discover a fire raise
- the alarm by activating the manual alarm point (near coat rack at entrance) and shouting "FIRE, FIRE, FIRE EVACUATE THE BUILDING". Once outside CALL 111
- DAYTIME the director will act as FLOOR WARDEN
   PINK VEST and follow procedures in the pocket. (i.e. making sure that doors and windows are closed behind you and that each area has been evacuated i.e. toilets. Please be aware of members requiring assistance an appoint someone to assist them. Once outside please report to the HEAD WARDEN RED VEST.
- NIGHTIME the director will act as HEAD WARDEN **RED VEST** and follow procedures in pocket. Head warden will immediately appoint 2 FLOOR WARDENS PINK VEST, before going outside to the ASSEMBLY POINT located at the Front of Building. One FLOOR WARDEN to ensure each area of Bridge club has been evacuated, then check other ground floor areas bike shop, rear carpet court storage, underground carpark and 1st floor apartment. One FLOOR WARDEN will check if the door to upstairs at ground level (i.e. next to bridge club entry) is unlocked if so, each premises door will need to be checked Monz Royal studio & storage rooms, Radio Wanaka, Dojo Room, Toilets and Kitchen/ Balcony.
- Only use the fire extinguishers if trained and it is safe to do so.
- DO NOT GO BACK INSIDE THE BUILDING

#### In case of EARTHQUAKE

- DROP COVER AND HOLD hold onto an internal wall or get under a table.
- DO NOT GO OUTSIDE
- The director will act as FLOOR WARDEN PINK VEST
- Avoid calling emergency services. Turn on local radio and listen for advice / instructions that it is safe to proceed outside or to the nearest Civil defence post at Mt Aspiring College.
- Conserve water and turn of the power if your see sparks.
- Keep account of everybody on a register
- Only allow people to leave if the building is unsafe or Emergency services have deemed it safe to leave.
