#### **News From the Committee**

#### **Improvers Lessons**

Our 2022 improver's lessons are held from 2:00 – 4:00 p.m. on the 3<sup>rd</sup> Saturday of each month, with the next one scheduled for this weekend. This month's lesson This lesson is a follow-up from our March lesson on transfer responses to a 1NT opening, introducing several new topics which we did not cover. These include transfer responses to a strong 2NT opening; minor suit transfers; handling interference by the opponents; when not to transfer; and opener's options if they hold four of the transfer suit. The lesson will consist of a brief (15-20 minute) presentation followed by play hands.

#### Beginners' Lessons Thursday night

These sessions have continued and will continue until the end of October. About 20 people have attended at least one lessons, and after falling as low as one table we are now up to three tables. Each lesson starts with a brief presentation with an example play hand displayed on

the big screen, but the main emphasis is on bidding and playing with plenty of help available. Thanks to the many bronze and silver volunteers who have helped with these lessons, and we will be in touch shortly to request further support for October.

#### **New Bridge tablets**

The new tablets are now up and running and were used for last weekend's tournament. They are currently not configured to show the hands and makeable contracts but we are working on this and hope to have them fully operational for club play in the near future.

#### New computer / laptop progress

Thanks once again to Mark Harry's generosity he has donated a 3 year old laptop from his business. Once we have installed the necessary software, including the Scorer programme used to record all club sessions, this will be a very welcome replacement.

#### Directors' training / refresher course

There is still a desperate need for more directors, with the current directing load falling heavily on a small number of shoulders. Marc is planning to shoulder tap some club members to encourage them to "volunteer" for this role. Please consider helping out as this role is vital for ongoing club activities.

#### **Mask Requirements**

Further to Marc's remarks earlier in this newsletter an additional consequence of making mask requirement optional is that Friday bridge players can now resume afternoon tea breaks, and Tuesday bridge seating for lunch can revert to "normal".

#### **Numbers for Bronze Championships**

The committee considered a suggestion from a bronze player that due to covid-related absences the number of playing sessions required to qualify for the Bronze Championships should be reduced from the current 8 out of 12 sessions. On

review it was decided to retain the status quo as, with three sessions still to play, reducing the total required to 7 would add at most three pairs to the current total of 11 potential qualifiers.

#### **WBC/Auckland Online Tournament**

This team tournament was played in August using Real Bridge. WBC players made up one 8-player team and everyone enjoyed it once players got the hang of it. This was a very positive activity for our club profile.

#### **Sydney Studio Offer**

Heather Olsen has written to us offering her Bali-themed studio in Sydney as a prize. This is a wonderful offer and we need to consider how we can best utilise this very kind offer.

#### **Online Lessons**

NZB are planning another set of online bridge lessons from 7:00 – 9:00 p.m. on Wednesday evenings, starting on 28<sup>th</sup> September and running weekly until the end of the year.

The full set of lessons is \$80, with the first introductory lesson free to give you a taster of online learning. You can <u>register</u> for the first lesson here.

Each lesson is a mix of theory and practice where you use the online RealBridge platform to play with live people and helpers at each table. It is a bit like a zoom call where you can chat and talk to others at the table while playing your virtual cards. NZB suggests that if a club sends anyone to lessons they also provide an assistant, so as to form a personal relationship with the learner and allow a welcoming transition from online to face to face bridge.

Once you have registered you will receive emails with more information closer to the date (a link to access the lessons and teaching resources).



#### When Not to Transfer

Transfer responses to an opening 1NT or 2NT are such a useful device that many players, once they are comfortable with their use, routinely use them whenever the opportunity arises. While this is sound practice 95% of the time, there is the occasional hand on which responder should think a little before automatically going into transfer mode. Here's a recent example from Round 2 of the Aspiring Stakes:



In response to South's opening 1NT North was never going to let the auction stop short of 4H, the only question being whether to bid game direct or to proceed via a transfer. At our table North chose not to transfer on the grounds that, as declarer, her two singletons would remain a closely guarded secret and make it that much harder for the defence.

At two of four tables where North became declarer in 4H East made the natural lead of the spade queen only to see dummy win with the ace, discard a losing club on the spade king, and – after losing two diamonds – ruff out West's last two diamonds to make her contract with an overtrick. Not so at our table: East, her suspicions aroused by North's failure to transfer, found the excellent lead of a small diamond allowing the defence to cash two diamonds and the club ace to hold declarer to her contract.

Playing double dummy careful defence holds N/S to 10 tricks regardless of who is declarer, so a more conventional transfer auction would not necessarily cost N/S. But the correct defence is not easy to find, and – as two other Easts found to their cost – it is all too easy to concede a trick. So for our table we can say well bid by North, but equally well defended by East. The result, thanks to good bridge on both sides, was a near-average score for each pair.
